Foundation Legal Notice under Dutch Civil Code & Private Contractual Standing

This Notice serves as formal, documented notification of my lawful intent to file and register a commercial lien against the property located at 54 Laan van Zuilenveld, 3611AJ, Oud Zuilen, Netherlands, currently owned by Jaap Mennink, under the following lawful grounds:

- Violation of private contractual agreements and lawful arrangements.
- Unlawful withholding of personal property belonging to the undersigned.
- Documented financial harm, emotional distress, and obstruction of peaceful resolution.
- Full non-compliance with prior Notice of Liability, Final Notice of Non- Compliance, and all subsequent lawful remedy opportunities.

Despite multiple documented opportunities to return my personal property, including my lawful attempt to retrieve belongings, you have failed to cooperate and have actively obstructed peaceful resolution. As a result, I am proceeding with the filing and registration of this commercial lien to secure outstanding damages and lawful compensation.

In accordance with the Dutch Civil Code (Burgerlijk Wetboek), relevant sections concerning personal property, tort (onrechtmatige daad), and private lawful claims, as well as recognized international remedy processes, I am asserting my lawful right to file and register a lien on the aforementioned property to secure outstanding damages and lawful compensation.

## **Amount Secured Under Lien**

The lien secures financial damages now exceeding EUR 22 million, based on:

Lawful private fee schedule established under the Freedom Collective Foundation, PMA.

Documented harm resulting from unlawful detainment, deprivation of rights, and ongoing obstruction.

Emotional distress, professional interference, and reputational damage.

The amount secured will continue to accrue until full remedy, peaceful resolution, and compensation are achieved.

## **Public Record & Next Steps**

This Lien will be:

- Registered with relevant Dutch property and land registry authorities (Kadaster).
- Shared with relevant public or private administrative bodies to prevent sale, transfer, or refinancing of the property until this matter is lawfully resolved.
- Escalated through lawful public and private remedy channels if obstructed or ignored.

## **Final Statement**

This process remains peaceful, lawful, and fully aligned with God's Law, Universal Law, and applicable sections of the Dutch Civil Code governing property, contractual standing, and remedy rights.

Failure to resolve this matter in good faith will result in continued lawful escalation, including but not limited to legal actions to secure equitable and legal interest in the property as part of the resolution of this matter.
